The proposed tax rate is not greater than the voter-approval tax rate. As a result, Collingsworth County is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Commissioners Court of Collingsworth County at their offices or by attending the public hearing mentioned above.
